Supervisor Fagan opened the Meeting at 6:14 p.m. A salute to the flag was conducted and a moment of silent prayer observed. Pastor Mark Appell of the Perth Bible Church then gave a blessing for the Town of Perth, it's officials and it's residents.

PUBLIC HEARING

Supervisor Fagan opened the Public Hearing at 6:19 p.m. on Local Law # 3-2023 entitled "A Local Law to Provide Real Property Tax Exemptions for Volunteer Firefighters and Ambulance Workers Pursuant to Section 466-A of the Real Property Tax Law".

No one was present to speak for or against the Law. Supervisor Fagan closed the Hearing at 6:45 p.m.

COMMUNICATIONS

The Communication as listed on the Agenda is filed in the Town Clerk's Office where it is available to anyone who wishes to see it.

UPDATE FROM STANDING COMMITTEES

Councilman Lewandowski reported for the **Dog Control Officer** that she is almost done with the Dog Census for the Town of Perth.

Councilman Lewandowski also reported for the **Youth Commission** that the State Inspector wants plastic cones put up between the grass and the asphalt driveway. Other than that, the State gave the Perth Youth Commission a good report.

Councilman Betz read the **Assessor's** Report, a copy of which will be filed with these minutes. Grievance Day went smoothly. There were four grievances. One was a property class change. One was a stipulation with an improvement code change, and there were two regular grievances that received reductions.

Acting Forman, Richard Wallace, from the Highway Department reported that the garbage pick-up changes are going well. The new truck with the electronic arm that picks up the trash cans is working well and it has made a huge cut in the time that it takes to pick up the Town's garbage.

Supervisor Fagan is hoping this new truck will enable the Highway Department to go back to picking garbage for two days instead of the three it now takes. Also, the new truck only needs one person to operate it which leaves two more highway employees to do other work for the Town, such as mowing and road work.

Town Attorney, Carmel Greco Esq. reported that Local Law #3-2023 entitled, "A Local Law to Provide Real Property Tax Exemptions for Volunteer Firefighters and Ambulance Workers Pursuant to Section 466-A of the Real Property Tax Law" is ready for adoption at tonight's Meeting.

Supervisor Fagan reported that the Memorial Day Ceremony at the Town Hall Complex was well attended. The Perth Bible Church also had a Memorial Day Observance on the Sunday before Memorial Day. Supervisor Fagan attended and stated that it was very enjoyable. The attendees sang patriotic songs and paid tribute to our veterans. **Supervisor Fagan** also stated that the Town has ordered new flags for the poles along County Route 107 from the Town Hall Complex to the corner with State Route 30 and along Route 30 both north and south to the Town of Perth boundary.

Supervisor Fagan went on to report that there is a proposal in the State to raise the deduction for Firefighters and EMT's that they are allowed to take from \$200.00 to \$1,000.00. However, they would have to decide if they want to take the income tax deduction or the property tax deduction offered by the Towns or Counties they reside in.
